

**LEGAL INVITATION FOR BIDS**

Sealed bids will be received by the County of Onslow in the Aviation Offices at Albert J. Ellis Airport, 264 Albert Ellis Airport Road, Richlands, North Carolina 28574, until **2:00 PM local time, August 25, 2022**, at which time they shall be publicly opened and read aloud in the Airport's Administration Conference Room for:

The Contract will include the rehabilitation of a 7100-foot bituminous aircraft runway, rehabilitation of a 200-foot by 200-foot blast pad, rehabilitation of six taxiway connectors, pavement markings, grooving, and minor electrical improvements.

There will not be a Pre-Bid Conference prior to the bid opening.

Bid security in the amount of five percent (5%) of the base bid will be required to accompany bids. Performance and Payment Bond shall also be required by the awarded contractor. The Owner reserves the right to reject any or all bids and to waive irregularities in bidding.

**Participation in the Owner's Disadvantaged Business Enterprise Program (DBE) will be 6.34%.** If the Contractor elects to use an DBE subcontractor(s), it shall be reported using the forms and procedures within this Contract.

This project will be bid as a single contract. Bid pricing shall remain firm for the duration of the project subject to the conditions noted in Section 40-02 of the contract General Provisions. Award of the contract is anticipated to occur within 30 calendar days of the bid. Notice to proceed with construction is anticipated to occur on or around **March 15, 2023**, except for certain preconstruction items noted herein. Bids may only be withdrawn as specified in NCGS 143-129.1.

All bids must be submitted in accordance with the Project Specifications.
